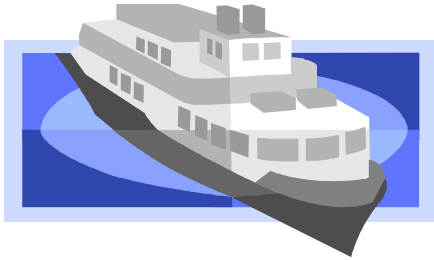




# DAIRYLAND WALKERS CANADA/NEW ENGLAND CRUISE & WALKS
